Memorandum of Understanding

SOCIAL POLICY ECOLOGY RESEARCH INSTITUTE (SPERI), a non-for-profit organization established on 05 June 2006 which is operating according to the Law on Science and Technology, and under the Certificate of Registration of Scientific and Technological Operation No A-525 issued by the Ministry of Science and Technology, with headquarters at Pham Huy Thong Street, Ngoc Khanh Science Village, Ba Dinh District, Hanoi Capital City – Vietnam.

Represented by **Tran Thi Lanh**, Founder and director of SPERI, having full legal capacity to sign this document

Hereinafter called SPERI.

The signatories have agreed as follows.

This MOU includes all the Annexes attached hereto, which form an integral part of the Agreement. It is effective from January 1st 2025 and will run until May 31st 2025.

Context

Secours Catholique Caritas France (SCCF) has a longstanding commitment to supporting Indigenous and local communities' livelihood security, focusing on sustainable agricultural practices in partnership with local organizations. Building on shared interests identified at the Pan amazon Social Forums and an environmental impact study on Indigenous communities, SCCF, with funding from the French Development Agency, developed a regional strategy on fair ecological transition in Asia. This strategy promotes land tenure security and sustainable resource management, aiming to bridge community and governmental interests through initiatives such as legal support, participatory mapping, and community-based monitoring.

Since November 2021, SCCF and its Asian partners have advanced this approach through regional workshops and webinars that address livelihood security, identify challenges, and develop tools for collective governance. These activities culminated in a logical framework and action plan, approved in May 2023, which seeks to build partners' capacity to help Indigenous and local communities secure agroecology farming, engage in sustainable management environmental protection.

This assignment is part of the following specific objective & output:

Objective 1: To strengthen the Asian partner organizations' capacities to support the Indigenous and local communities (IPLC) land tenure security and sustainable management

Output 2: The Asian partner organizations have adopted new practices to foster collective and inclusive landscape governance and sustainable natural resources management

About the partners

SPERI (Social Policy Ecology Research Institute) is a research institute created in 2006. Through farmer networks, SPERI works towards an inclusive society in which indigenous peoples and ethnic minorities enjoy equal access to social justice, gender equality, natural resources and equitable socio-economic systems. They are driven by their concept of livelihood sovereignty and have an extensive expertise in sustainable land governance and agro-ecological farming.

KMSS Loikaw is one of the 16 components of KMSS Myanmar, the Burmese Caritas network, officially registered as an NGO. It is actively engaged in the integral human development of the population of Karenni State regardless of their religious affiliations, ethnicity and locality, in particular through programs focusing on the health, education, social protection, livelihood and emergency aid sectors. The SCCF has been working with KMSS Loikaw since 2017 on agroecology and community development. On this project, the SCCF is also collaborating to some extent with KMSS Taungngu (created in 1996) and KMSS Pekhon (created in 2006), which are participating in the project under the leadership of KMSS Loikaw.

ARTICLE 1 - PURPOSE OF THE AGREEMENT

This MOU formalizes cooperation between SCCF, KMSS and MASS for an exposure and learning visit of 7 (seven) KMSS team members to SPERI in Vietnam for about 2 months between February 2025 and April 2025. KMSS will deepen their learning on watershed land & forest co-governance, management, protection and carbon restoration via agro-ecology land use farming practices (training of trainers). SPERI will host and lead the training programme while SCCF will support its organisation and follow-up its implementation.

ARTICLE 2 - MUTUAL OBLIGATIONS

KMSS' commitments:

- Active participation in the exchange programme, ensuring that its designated staff and relevant stakeholders attend and engage actively in all scheduled sessions;
- Logistics and finance: KMSS will cover all the costs related to their travel to and stay in Vietnam through already-confirmed projects.
- Post-training implementation: KMSS will apply the training outcomes in their community projects, report on impacts, and provide regular updates to SCCF.

In addition, the relevant staff from KMSS, will:

- Prepare a report with recommendations, and feedback on the training process jointly prepared with SPERI.
- Report on the training outcomes and impact at the community level in a report to be sent 6 months after the completion of the exchange, towards November 2025.

SPERI's commitments:

- Leading the exchange programme: SPERI will organise the schedule, and with the support of external experts (CV and ToRs in annex) conduct the training and facilitate the learning process for the KMSS team.
- Availability of personnel: SPERI will ensure that the appropriate personnel are available and present throughout the training program to accompany KMSS, including but not limited to key decision-makers and previous FETRA focal points;
- Logistical support: SPERI agrees to take the necessary steps to facilitate the attendance and participation of all relevant personnel and community leaders, providing logistical support as needed to encourage full engagement and the achievement of training objectives;

Secours Catholique/Caritas France's commitments:

- Coordination support: SCCF will provide support in ensuring smooth coordination between KMSS and SPERI.
- Financial support: SCCF will cover the costs of SPERI related to the hosting and organisation of KMSS. See budget attached.
- Organize regular check-ins and clear communication between Secours Catholique / Caritas France, KMSS and SPERI.
- Facilitate the lessons learned process and follow-up of the action planning exercise at the end of the exchange programme.

ARTICLE 3 – TRAINING SPECIFICS AND IMPLEMENTATION

- The training will focus on landscape design, land use and land management and on livelihoods especially on agroecology models, practices, and products development.
- The exchange programme will consist in various theoretical sessions, practical training and field visit with key members of SPERI's network.
- 7 team members will participate in this exchange opportunity;
- Post training follow-up: KMSS aims to strengthen the capacity of its key staff so that some practices and approaches related to landscape design and agroecological farmings could be replicated in Myanmar.

ARTICLE 4 – FINANCIAL ARRANGEMENTS

Secours Catholique / Caritas France will reimburse all eligible training-related fees and expenses shared by SPERI. Reimbursements will include, transportation fees, meals/ catering expenses, rental of a venue, stationery and copies of materials, and fuel costs for follow-up activities. A provisional budget has been approved and is attached as an annex to this MoU. SCCF will also reimburse SPERI / the experts identified by SPERI as per the agreement in annex.

SPERI will submit a final financial report by April 30th, 2025, summarizing all expenditures and including necessary receipts. Secours Catholique / Caritas France will process reimbursements within three weeks upon receipt and verification of original invoices and relevant supporting documents.

ARTICLE 6 – SETTING OF DISPUTES

Any disputes will first be addressed through amicable negotiation. Failing resolution, the matter will fall under the exclusive jurisdiction of the Tribunal de Grande Instance de Paris.

TERM OF REFERENCE TRAINING OF TRAINER PROGRAM OF MYANMAR'S FELLOWS

Training of Trainer Program on Watershed Land & Forest Co- Governance, Management, Protection and Carbon Restoration via Agro-Ecology Land Use Farming Practices Toward Fair Ecological Transformation and Product Enterprising for Rural Area Strategy in Southeast Asia

Located Target is Successful Communities in Central Vietnam and HEPA's Eco-Farming School 2024-2026

(Tentative for February 15, 2025 to April 15, 2025)

I. Introduction:

KMSS is implementing a project on land mapping documentation of customary land use as a support to ensure the security of customary land ownership/User and resource management in the indigenous communities, Myanmar. The outputs of land mapping and documentation, such as maps and PAR¹ lesson gained will become advanced input for local people after two months internship. These are also aimed for the long term at enhancing land use & land governance, and forest & resource management of the local community, therefore, to strengthen capacity of the local people in understanding land mapping, land use planning as well as co-natural resource governance is not only important for local farmer, but also for the organization who work with local farmer such as KMSS and any fellow in contribute lessons and experiences which we have been gaining over the decade for further policy either making or implementation.

This internship program comes after the first visit of KMSS to SPERI which took place in February 2024 for seven days. During the visit, we explored the Vietnam Ethnology Museum, Cao Quang district, and the HEPA Eco Farming School and Forest Areas.

The objectives were:

- > To gain knowledge about action research in support of and preparation for policy contribution.
- ➤ To acquire knowledge about showing value of customary practices related to land governance, natural resource management, and forest management. This also includes how to build network of farmers for enhancing their livelihood.

To learn about good practices of agroecology.

During the exposure visit, participants had the opportunity to engage in discussions and learn about various topics such as agroforestry, forest management, eco farming, co-governance of landscape, crop rotation farming systems, making organic compost, and practical policy contribution by SPERI and key farmers towards forest department/government and company members.

The exposure was a valuable experience, but it was too brief to fully acquire the knowledge and skills related to the activities and topics the KMSS team learned about in the exposure fields. Therefore, KMSS intends to maintain our collaboration with SPERI for further learning and sharing. There are certain aspects that are crucial for long-term continuation and integration into our future activities, such as

establishing landscape management committees, introducing agroecological farming practices to interested communities and households, promoting diversified home gardening.

On the final day of the trip, the two partners developed action plans in expectation of further knowledge increase and capacity development with regard to co-governance of landscape and agroforestry/agro-farming. The action plans included to send 7 participants from Myanmar Fellow to visit Vietnam and pursue a deeper learning experience from farmers who have been successfully more advanced in those above issues. Therefore, going beyond but taking a step further from the objective of the previous visit, we come up with this proposed program for more effective learning and deepening the capacity of key staffs.

II. Program Objectives:

The participants' knowledge, experiences and skill is enhanced and they have the capacity to replicate or integrate the new learnings to their project/with their community:

- 1. on landscape design, <u>land use and land management</u>, through customary law understanding and documentation methodology, of Local Community Based Watershed Forest-Land Co Governance
- 2. on livelihoods especially on agroecology models, practices, and products development which is directly supporting local native seed, local knowledge, local people livelihood security and wellbeing amongst Myanmar and Vietnam for long term positive transforming cooperation.

III. Expected Outcomes:

By the end of the internship program,

- 1. Participants are familiar with the concept of Livelihoods Sovereignty and 3R, as well as landscape designing, and are comfortable with SPERI's approach to Land and Forest Use Management as well as Co-Governance.
- 2. Participants get inspiration from successful case studies of Land and Forest Management either agriculture or forestry.
- 3. Local product/seeds/practices are exchanged between Myanmar and Vietnam
- 4. Community Agro-Ecology Enterprising practices are explored for potential replication in Myanmar.
- 5. Participants learn by doing and contribute to SPERI's work/activities relevant to their objectives.

IV. Key learning areas

1. Field observing, discussion and learning and between Vietnamese Key Farmers, Authority and Researcher for both side towards Land and forest Co-Governance, Farming, Product

- Enterprising and Niche Marketing Skill as well as legal supporting processes over the changing of rural economic policy;
- 2. How to change mindsets and practices on land conversion through agroecological solutions (analyzing the harm of monoculture, conducting the study, identifying solutions, implementing them, etc.)
- 3. Learning from land use owners about neighboring cooperation in Management, Preservation and Protection their Community Forest and Land Mapping towards CO-Governance; as well as Field practicing and applying traditional knowledge and technical skills in forest reserves audit and measuring (timber, herbal plants, above ground biomass and carbon stock): using GPS, identifying random plots, identifying species and their use, field measuring, analyzing the data.
 - Field practicing and applied skill of using GPS in identifying random sample for measuring Carbon Stock in above ground biomass of Land User as well as neighboring cooperation towards CO-Governance, Management, Preservation and Protection their Community Forest and Land Mapping;
- 4. Field observing, interviewing, touching and testing community ecological product such as native nurseries, Bee hive and honey, agro-ecology gardening and self-sufficiency livelihood of eco-farmers as well as how they approaching Eco- Niche Marketing to Ho Chi Minh, Ha Noi and Consumer around the country
- 5. How does local community transform into community enterprising their ecological product by community entrepreneurial (Ly May Chan- Tan phin; May Sai duan, Mai Thuy Huyen Cao quang; Hoang Huu Phuoc Lam trach; Nguyen Thi Binh Lam trach, Nguyen Duc Su Cao quang case studies, etc)
- 6. How does Key Farmer Organizational Action transferred into YIELDS-AGREE and moving to Community Entrepreneurship Institutional Development (CENDI) and now dealing with policy analysis
- **V. Program Duration:** The internship program will last for 2 months.

VI. Participants:

<u>Criteria for selection</u>: participation in the first field visit in Vietnam, fluency in English with capacity to translate to others (at least half of the team), valid passport, commitment to the SECURE programme, commitment to share and transfer knowledge to their colleagues/communities.

There will be seven participants from KMSS to join the internship program. 3 will be from KMSS-Loikaw, 2 will be from KMSS-Taungngu, 2 will be from KMSS-Pekhon. It includes staffs from the current land and customary rights project as this learning program is planned as ToT training and the participants will in return share back the knowledge to the communities in Myanmar.
